


Objectives and Targets of the Safety Committee

- Power consumption reduction, 1 - 2% every year or 4 - 6% in 3 years
- Water consumption reduction, 1 - 2% every year or 4 - 6% in 3 years
- Ensure personal protection equipment usage in the identified work zone areas
- Achieve safety training coverage to 20% of total manpower in a year
- Minimize accidents / incidents

Activities of the Committee

- Providing an overall objective analysis of the field safety activities.
- Perform periodic sites inspections involving the site safety committee members.
- Keeping the injury and accident record.
- Keeping the Safety Inspection Report
